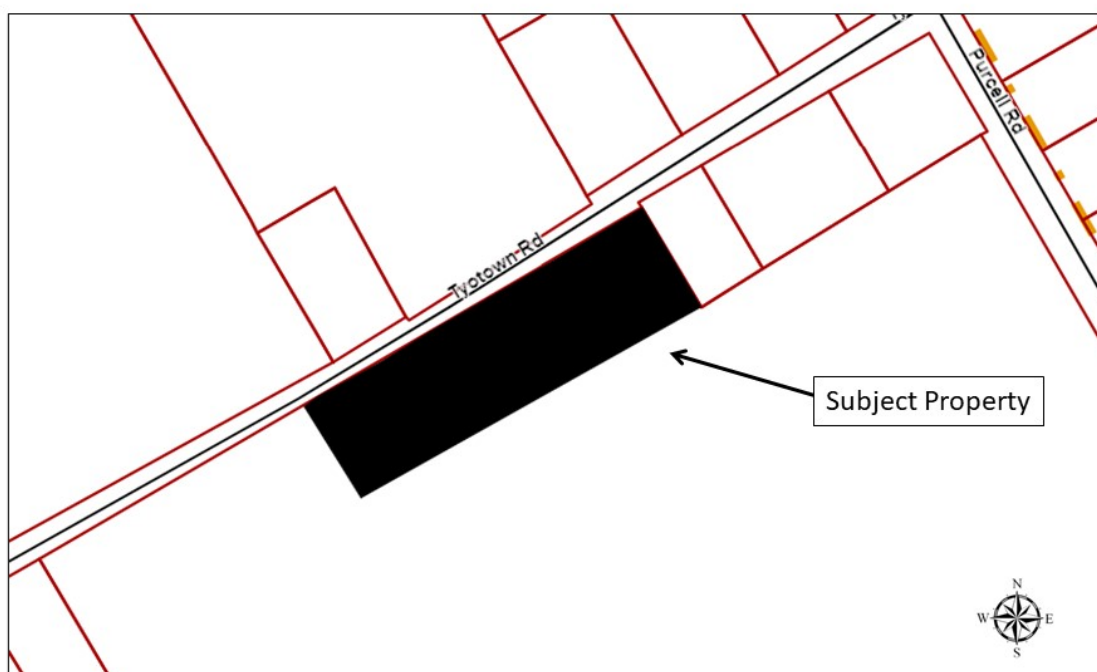

The subject property is located on part Lot 37 to 39, Registered Plan 101, (the former Township of Charlottenburgh) now in the Township of South Glengarry, consisting of approximately 2 hectares of land.



The applicant intends to develop the parcel of land for a single detached residential use development consisting of 5 residential lots which are proposed to be serviced by private wells and septic systems. Access to the lands will be provided from Tyotown Road.



ANY PERSON may participate in the public meeting and/or make written or verbal representation either in support of or in opposition to the proposed Plan of Subdivision. If a person or public body that files an appeal of a decision of the United Counties of Stormont,

Dundas and Glengarry in respect of the proposed plan of subdivision does not make oral submissions at a public meeting or make written submissions to the United Counties of Stormont, Dundas and Glengarry before the proposed draft plan of subdivision is approved or refused, the Ontario Municipal Board may dismiss all or part of the appeal.
