Notice of Public Meeting Concerning a Proposed Building By-law with New and Amended Permit Fees

TAKE NOTICE that the Council of the Corporation of the Township of South Glengarry will hold a public meeting on **Monday February 23, 2026 at 6:30 pm** in Council Chambers (Tartan Hall) at **19740 John Street, Williamstown, Ontario**, in order to consider the passing of a by-law to adopt new and amended building permit fees imposed under Section 7 of the Building Code Act.

PURPOSE AND EFFECT

The Township of South Glengarry has conducted a review of building permit fees under Section 7 of the Building Code Act. The purpose and effect is to increase and decrease existing fees, and introduce new fees for permits and services that traditionally have not had fees. Information will be provided at the meeting on the amount of the proposed fees and the rationale for changing and imposing the fees.

ANY PERSON may attend the public meeting and/or make written or verbal representation either in support of or in opposition to the proposed building permit fees.
