## **South Glengarry Fire Service Successfully Recertifies Superior Tanker Shuttle Accreditation**

**South Glengarry, ON – September 10, 2025**– The Township of South Glengarry is proud to announce that the South Glengarry Fire Service has completed its recertification for the **Superior Tanker Shuttle Accreditation (STSA)**.

The recertification, granted on July 2, 2025, is valid until December 31, 2030. It confirms that the Township's five fire stations, Glen Walter, Martintown, Williamstown, Lancaster, and North Lancaster, continue to meet the Fire Protection Survey Services standards and have demonstrated the ability to deliver water to rural fire scenes to protect the community. The South Glengarry Fire Service exceeded this standard during testing, achieving 3,000 litres per minute (642 I.G.P.M.).

"This recertification acknowledges our department's fire prevention and response capacity. Municipal investments in both our personnel and fleet allow the South Glengarry Fire Service to continue to provide a high level of fire protection to this community," said **Dave Robertson, CMMIII, Fire Chief**.

The Superior Tanker Shuttle Accreditation is recognized by many insurance providers and may help lower fire insurance premiums for rural homeowners without access to municipal hydrants. Homeowners and businesses in the Township may be eligible for a reduction in their insurance rates and are encouraged to contact their insurance provider directly for details.
