THE CORPORATION OF THE TOWNSHIP OF SOUTH GLENGARRY BY-LAW NUMBER 2025-45

BEING A BY-LAW TO AUTHORIZE THE SEASONAL CLOSURE OF SPECIFIED SIDEWALKS, BEING PART OF A HIGHWAY UNDER O. REG 239/02, MINIMUM MAINTENANCE STANDARDS FOR MUNICIPAL HIGHWAYS, ON A SEASONAL BASIS.

WHEREAS the Municipal Act, 2001, c. 25 S. 5 (1) provides that the powers of a municipal corporation are to be exercised by its Council;

AND WHEREAS the Municipal Act, 2001, c. 25 S. 5 (3) provides that the powers of every council are to be exercised by By-law;

AND WHEREAS the Municipal Act, 2001, c. 25 S. 34 authorizes a municipality to pass a by-law to permanently close a highway or part of a highway;

AND WHEREAS O. Reg. 239/02 defines a "sidewalk" as the part of the highway specifically set aside or commonly understood to be for pedestrian use, typically consisting of a paved surface but does not include crosswalks, medians, boulevards, shoulders or any part of the sidewalk where cleared snow has been deposited;

AND WHEREAS O. Reg. 239/02 states that when a municipality closes a highway or part of a highway pursuant to its powers under the Act, the highway is deemed to be in a state of repair in respect of all conditions described in O. Reg. 239/02 from the time of the closure until the highway is re-opened by the municipality, and that notice of the seasonal sidewalk closure has been conducted via approved municipal communication methods.

AND WHEREAS Council deems it expedient to authorize the seasonal closure of specified sidewalks.

NOW THEREFORE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF SOUTH GLENGARRY ENACTS AS FOLLOWS:

- 1. THAT all sidewalks in the Township of South Glengarry, save and except the sidewalks identified in Schedules "A" and "B", attached hererto and forming part of this by-law, will be closed on November 1st of each year and re-open on April 1st of each year.
- 2. THAT every person who uses a sidewalk so closed does so at their own risk and the Township of South Glengarry is not liable for any damage sustained by a person use the sidewalk so closed to traffic.
- 3. AND FURTHERMORE, THAT any by-law inconsistent with this by-law is hereby repealed, including By-law 70-2020 and By-law 2024-73.


Schedule 'B' - Winter Maintained Sidewalks Map
